Four simple and efficient ways to leave a charitable bequest to Nurturing Minds

- **Last will and testament:** Add a codicil to your will for Nurturing Minds
- **Living trust:** Add an amendment to your revocable trust for Nurturing Minds
- **Retirement plan:** Designate Nurturing Minds to receive a percent or all of an IRA or Keough (contact your plan administrator for forms)
- **Life insurance:** Designate Nurturing Minds as the beneficiary to receive a percent, or the entirety of the proceeds (contact the policy's administrator for forms)

Giving retirement plan assets via a bequest

While retirement plans are a great way to accumulate assets for your use during retirement, they can be a costly way to pass assets to your loved ones because the taxes imposed diminish the value of these assets. By naming Nurturing Minds as the beneficiary of retirement plan assets, you can ensure that 100% of the value of the asset is put to use educating girls in Tanzania.

How to get started

Text for including Nurturing Minds in your last will and testament

Specific Bequest: "I give to Nurturing Minds, Inc. (address), the sum of \$_____ to be used by its Board of Directors (as it deems appropriate) OR (to invest in its permanent endowment fund) OR (according to a statement of donor intent previously agreed to by Nurturing Minds, Inc. and me.)"

Residuary Bequest: "I give to Nurturing Minds, Inc. (address), ____ percent of the residue of my estate to be used by its Board of Directors (as it deems appropriate) OR (to invest in its permanent endowment fund) OR (according to a statement of donor intent previously agreed to by Nurturing Minds, Inc. and me.)"

Contingency Bequest: "In the event that _____ predeceases me, I give to Nurturing Minds, Inc. (address) (the sum of \$_____) OR (_____ percent of the residue of my estate) to be used by its Board of Directors (as it deems appropriate) OR (to invest in its permanent endowment fund) OR (according to a statement of donor intent previously agreed to by Nurturing Minds, Inc. and me.)"
